- ✦ **HKAS is part of Innovation and Technology Commission of the Hong Kong Special Administration Region (HKSAR) Government.**

- ✦ **It was set up in 1998 (previously known as HOKLAS since 1985)**

- HKAS provides accreditation services to testing laboratories, certification bodies and inspection bodies through the following 3 schemes:

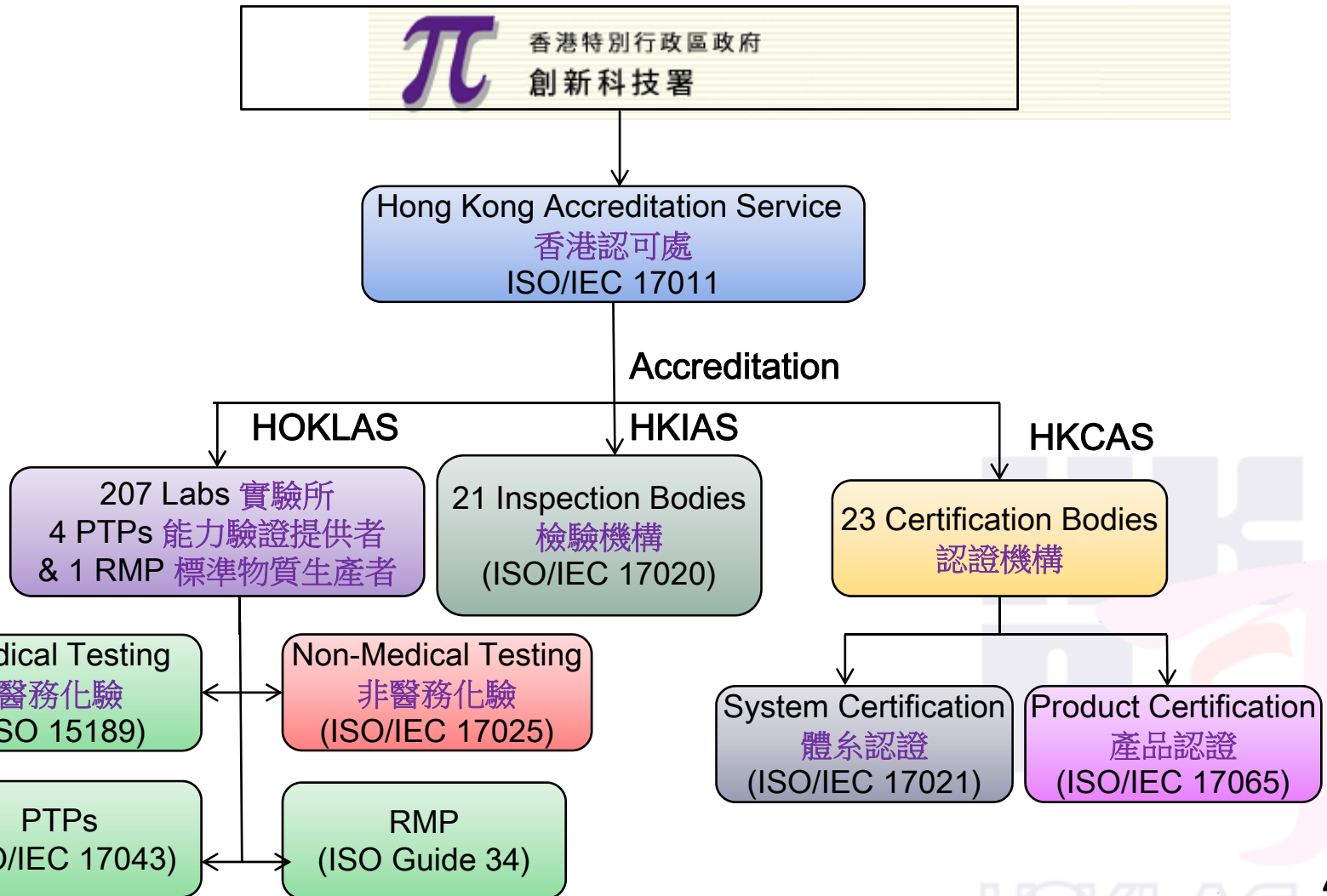

Chinese Medicine Testing Services

中藥測試服務

- Chinese medicines are tested for safety and quality
中藥測試包括安全及品質項目
- Safety tests include:

 - Heavy metals and toxic elements, e.g. of cadmium, lead, mercury, arsenic, etc.
重金屬及有毒元素，如鎘、鉛、汞、砷等含量
 - Pesticide residues, e.g. contents of organochlorine pesticide residues
農藥殘留，如有機氯農藥殘留量
 - Microbiological examination, e.g. aerobic bacterial count, yeast and mould count, Salmonella, etc.

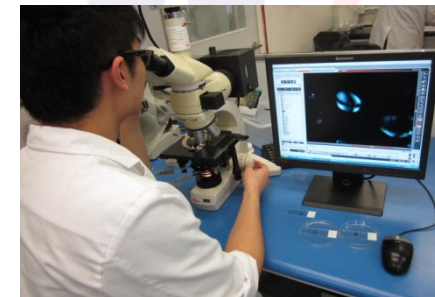

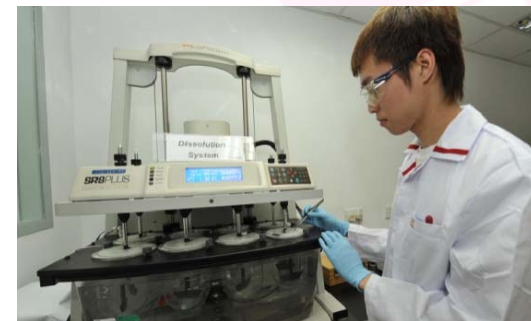

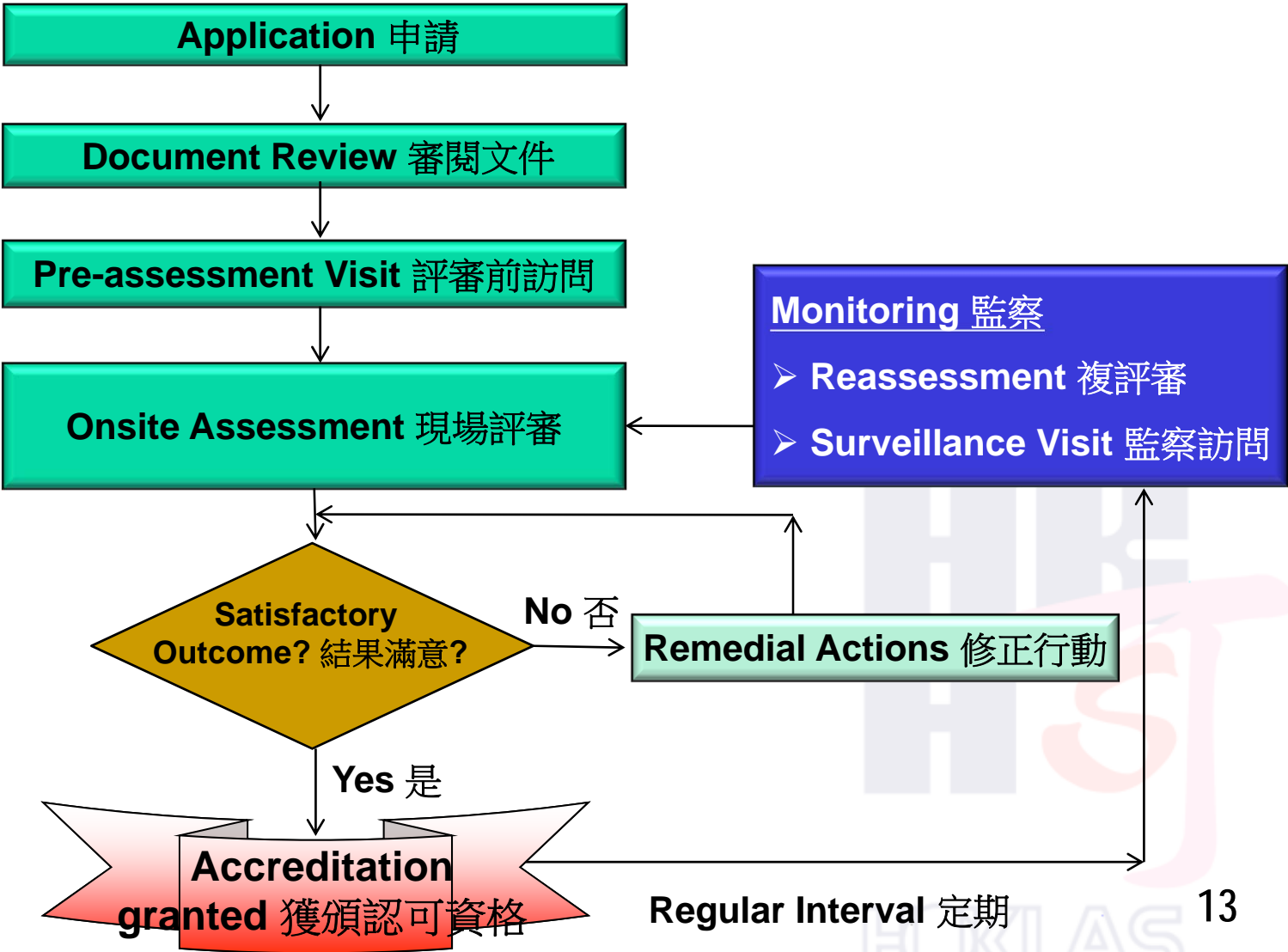

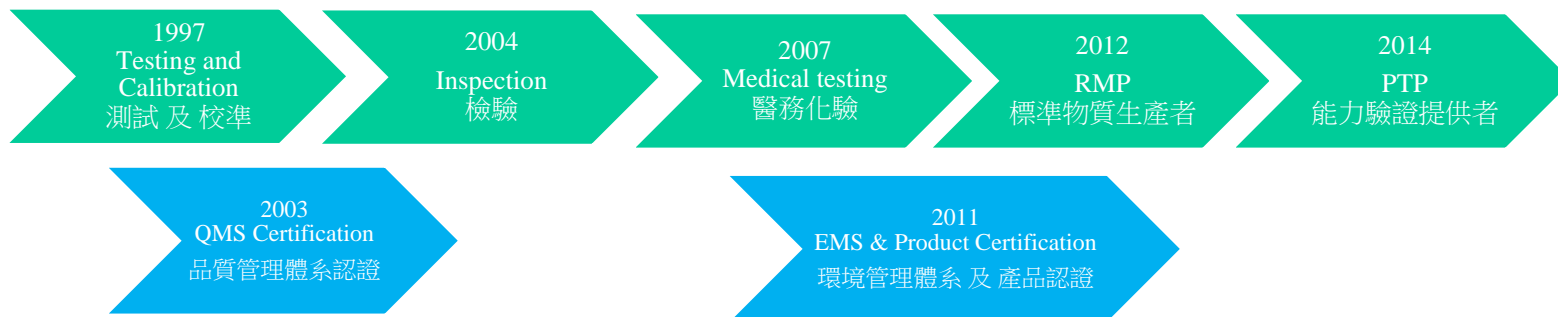

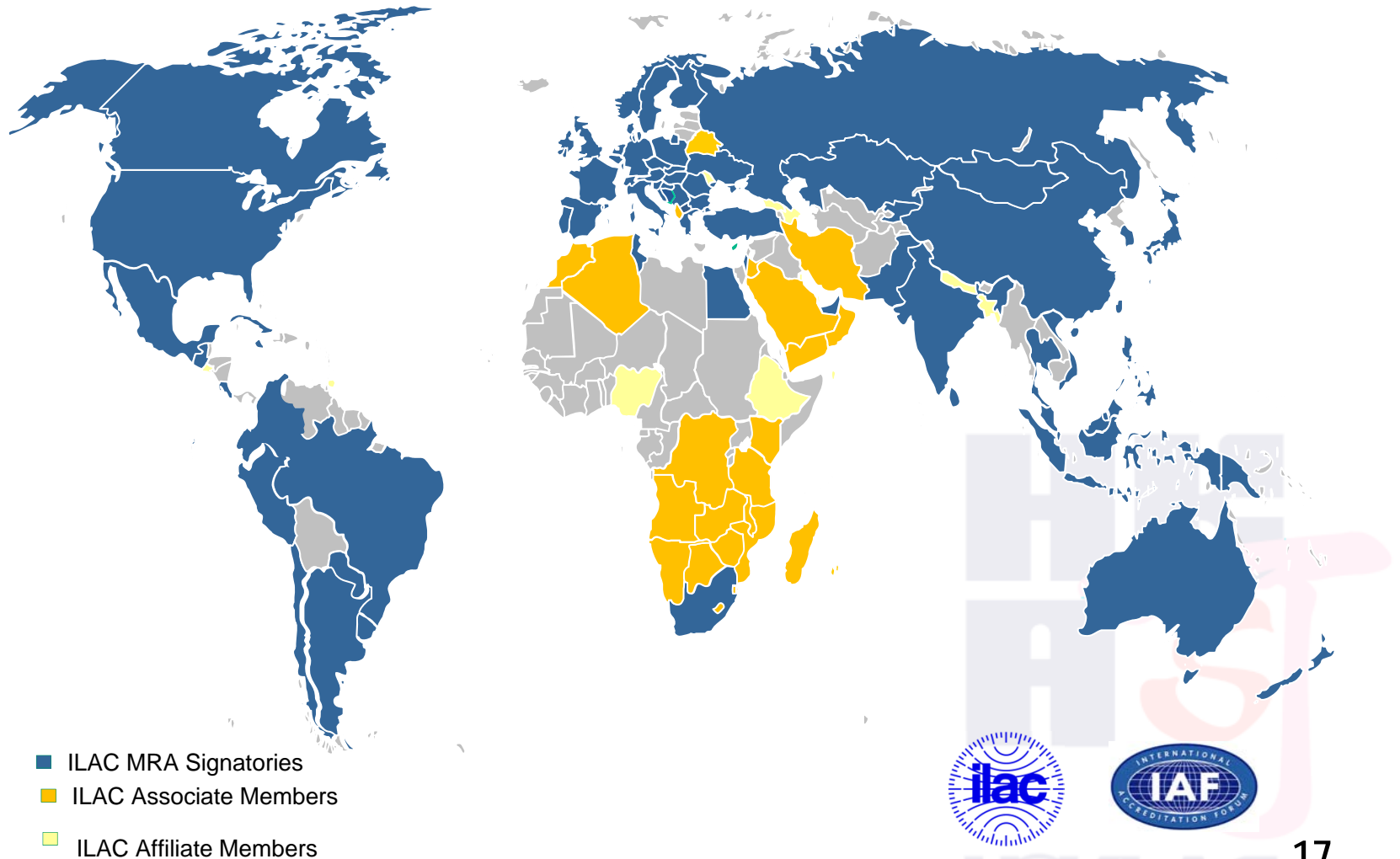

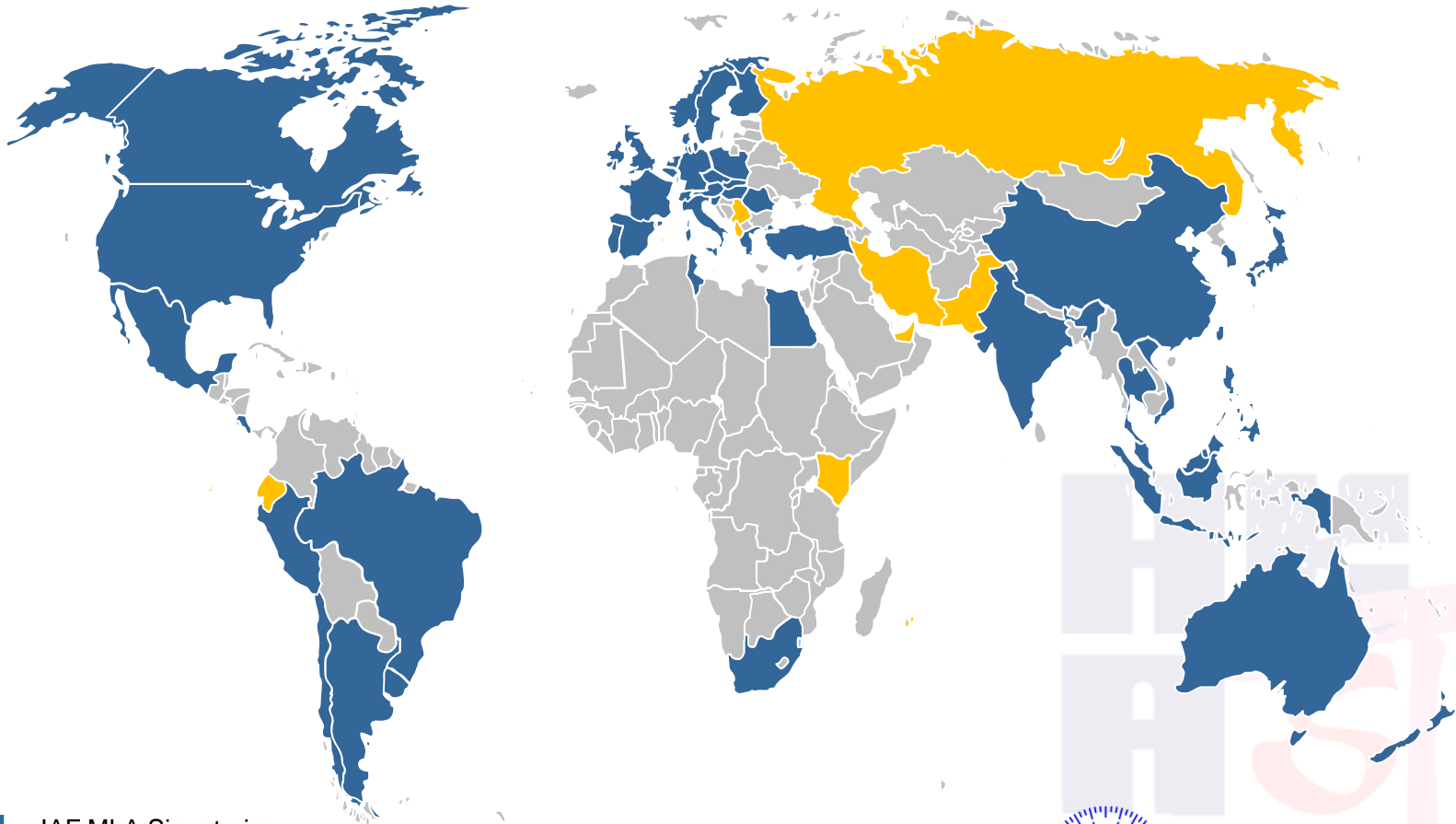
Coverage of the ILAC MRA (March 2015)

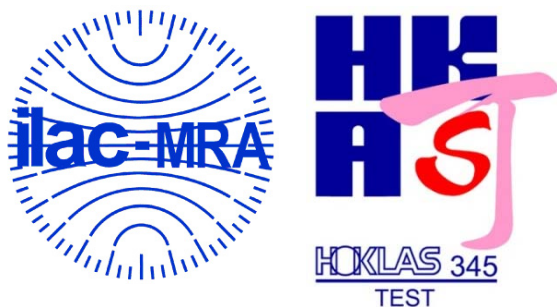

Accreditation Services for Testing and Identification of Chinese Medicines

與中藥測試及鑒別有關的認可服務

- **Microbiological examination and quality testing of pCm to the Pharmacopoeia of the PRC, e.g. microbial limit test, general requirements for preparations, etc.**

根據《中國藥典》對中成藥進行的微生物檢查及品質性測試，例如微生物限度檢查法、製劑通則等。

- **Testing of pCm and CMM for heavy metals, toxic elements and pesticide residues.**

測試中成藥及中藥材中的重金屬、有毒元素及農藥殘留含量。



- **Safety, chemical and physicochemical testing of CMM to the HKCMMS, e.g. aflatoxins, assay, ash, water content, extractives, etc.**

根據《香港中藥材標準》對中藥材進行的安全性、化學及理化測試，例如黃曲霉毒素測試、含量測定、灰分、水分、浸出物等。



- **Physicochemical and chromatographic identification of CMM to the HKCMMS.**

- **Microscopic identification of CMM to the HKCMMS.**

- **Accreditation service may be provided to laboratories performing individual tests given that the relevant accreditation criteria are fulfilled, e.g. assay of specific chemical markers in pCm**

Proprietary Chinese Medicine Testing Laboratories

中成藥測試實驗室

In the registration of proprietary Chinese medicines (pCm), the Chinese Medicine Board (CMO) of the Chinese Medicine Council of Hong Kong accepts endorsed test reports issued by accredited pCm testing laboratories.

在中成藥註冊時，香港中醫藥管理委員會中藥組會接納獲認可中成藥測試實驗室所發出的認許測試報告。



If a laboratory has been collectively accredited for testing of pCm for toxic elements & pesticide residues; and microbiological examination of pCm according to the Pharmacopoeia of the PRC, the CMO will also accept reports of other tests required for pCm registration (e.g. stability test) issued by the same laboratory.

如果實驗所同時已獲取測試中成藥中有毒元素、農藥殘留及按《中國藥典》進行的微生物檢查的認可資格，中藥組亦會接納該實驗所發出有關中成藥註冊的其他測試項目(例如穩定性測試)的測試報告。

Certification of Chinese Materia Medica

中藥材認證

- Through its Hong Kong Certification Body Accreditation Scheme (HKCAS), HKAS is providing accreditation service to local certification bodies, including those providing public certification service for products. The products involved are mainly construction materials, consumer products and food (not including Chinese medicine at present). The applicable accreditation standard is ISO/IEC 17065.

透過香港認證機構認可計劃 (HKCAS)，香港認可處向本地認證機構提供認可服務，當中包括為公眾提供產品認證服務的認證機構，而相關產品主要包括建築材料、消費品及食品(暫不包括中藥)，所採用的認可標準為 ISO/IEC17065。

- **The Hong Kong Productivity Council (HKPC) has recently issued a new certification scheme viz. ‘Product Certification Scheme for Chinese Materia Medica’ specifying criteria for certification of Chinese Materia Medica.**

香港生產力促進局 (HKPC) 最近推出了一個新認證計劃「香港中藥材認證計劃」為中藥材產品提供認證準則。

- **HKAS is ready to provide accreditation service to those certification bodies who are interested in providing certification service according to the scheme.**
